We've come through most of the winter with very little snow or hazardous weather. The New Year's Eve party was well received, and we've already started making notes for upcoming events.

Social: The Board is planning to have Evening in Little Italy Saturday, February 11, 2017. Advance registrations required by February 08, at noon. mmgeyser@gmail.com, or call and leave a message on the club phone. Minimum number required in order to hold the event. The Public is invited to the never-ending pasta event.

Clubhouse: We will be hosting a spring cleaning day in early March, which will be voluntary. There will be work on the deck outdoors in addition to cleaning inside. At the present, the Board is advertising for a manager.

Membership: The moratorium on Stock discounts is now in effect. Our structure for this year will be as follows:

<u>Full Golf:</u>	\$825 membership, \$50.00 equipment fund fee, \$240 for club credit
<u>Single Golf:</u>	\$675 membership, \$50 equipment fund fee, \$240 for club credit
<u>Social:</u>	\$350 membership, \$25 equipment fund fee, \$150 for club credit

We will also be offering a reduced membership for new members (not a member in the past ten years). This year will be our trial year with club credit. This can be used for pro shop, meals, or beverages. If the membership indicates that they do not wish to support dining service, based upon attendance/usage, the board will move toward further reducing dining options in the future.

The Board is **strictly enforcing payment of dues.** We have several payment options, including quarterly and monthly drafts. If you are in arrears, you must make payment arrangements with Kim Chadwell. Failure to do so will result in posting on the Club Board. You will not be permitted to use any of the Club amenities until payment is made.

Cart Sheds: Contact Patrick Sheik if you would like to rent a shed. If you know of an occupied space by someone who is no longer a member, please contact Patrick. Please do not find it necessary to have electric appliances that are a drain, such as ice-boxes.

Pool: David Remmers has done a great job with the pool oversight the last several years. We are looking for someone to take the lead on the pool for the summer, including clean-up. Contact Lynn or Kim if you are interested or know of someone who might be.

Course: We have joined the KanNeb group for the coming year, which will be for senior men. More information will be presented. No outside alcohol should be brought onto the course. Members are responsible for their guests paying green fees.

Stag: The Board is in the process of forming a men's league to take place the alternate Wednesdays from the organized play events. More details as they are worked out and finalized.

Alumni Weekend: The tradition of the ten-year reunion class hosting a dance party at the Club has ended. The clubhouse will be available for the use of alumni groups if they wish on Friday evening, Saturday (both before and after the banquet), and Sunday. Please contact the Club e-mail if you would like to bring a group.

Board: There are two seats open on the current Board of Directors. Our by-laws were amended to allow either a seven-person or nine-person board, with the emphasis being on an odd number at any given time, meaning two must come on at the same time. During the winter, we have gained Mark Heiniger (course), and Brian Sinning (tournaments). This leaves social and clubhouse. The Board is quite willing to put those two categories together into one position and have a pool committee head as the ninth position. This position wasn't necessary when David was employed by the Club. We are currently meeting every second Monday.
